**5. ALP Committee Updates**

*Wool Committee: Updated the board about the poor turnout to the CFW shearing webinar. Only 2 non-board members were present. Hopefully the next webinar on April 24 will be better attended by producers.*

*Marketing Committee: Vice Chair reported on the CS Sheep Committee and reiterated that ALP was firm on having the final say on the videos if we are contributing \$2500.00 towards the project. Vice Chair has not had a response from them since the meeting however their committee chair was near her due date which could be why we haven't heard back yet.*

**Action: Board would like to proceed with the videos even if the project doesn't work out with the CS Committee.**

*Large producer Consultation Committee: Vice Chair spoke with a larger producer and asked*

*them to spread the word to other large producers about this meeting.*

*National Committee: All agricultural groups are encouraged to send letters against Bill C-293. The board feels there are significant red flags with this bill and we need to take action.*

## **6. Proposed Traceability Regulation Changes**

The board feels that there are still many lingering questions about how the changes will be policed and managed, especially movement. Also many producers are likely to be unhappy about the electronic tracking and having to come up with the finances to invest in the necessary handling equipment for these changes.

**Action: ALP to reach out to the GoA to collaborate on a webinar or possibly do our own so that producers know that we are taking this seriously and giving them the information directly instead of through other channels.**

It was a unanimous decision by the board that the CSF should not be the responsible administrator of our traceability program and ALP does not support them in their request. ALP proposes CCIA to remain as the responsible administrator.

## **7. Letter to CFIA**

**Action: ALP supports CCIA remaining as the responsible administrator for our traceability program and will proceed with drafting the letter to CFIA stating our concerns and perspective.**

## **8. Letter of Intent (LOI) submitted to ALP for funding in 2023-24**

**Motion: ALP is in support of Olds College's research project called: Improving sheep production efficiency by genomics and metabolomics blood biomarkers of feed efficiency and subclinical parasite infection and will contribute a monetary investment of \$6000.00. Seconded.**
